NRLN Launching IBM / Kyndryl Retirees Chapter

In February, the NRLN began the process of launching an IBM / Kyndryl Retirees Chapter. IBM retirees were among the founding members of the NRLN. Kyndryl was spun off from IBM in November 2021 as the world's largest provider of IT infrastructure services.

The NRLN is investigating whether there was an injustice to IBM retirees when IBM changed healthcare offerings to retirees. On September 14, 2022, IBM announced that on January 1, 2023, U.S. retirees would be prevented from using Future Health Account / Healthcare Reimbursement Account (FHA/HRA) funds to pay for anything other than the two Medicare Advantage plans specified by IBM. The NRLN is endeavoring to gain additional information through an online survey to help determine whether IBM must offer retirees a Supplemental Enrollment Period (SEP) and "Guaranteed Issue Rights" for a Medigap plan under Medicare Federal law.

IBM retirees are requested to participate in the NRLN's brief survey to provide their input about IBM's change to retirees' healthcare coverage and the impact that it has had on them and their family. The survey is available at: <https://surveymonkey.com/r/NRLNIBM> .

NRLN Legislative Committees' Work

The NRLN's Legislative Advisory Committee (LAC) composed of Judy Stenberg, Chairwoman, Deb Morrisett, Joe Mazzei and Al

Duscher prioritizes retirement-related bills it reviews during its twice-a-month conference calls. The LAC submitted the following bills for the Legislative Action Priorities Committee (LAPC) to consider for action.

The LAPC, which includes Bill Kadereit, Chairman, Judy Stenberg, Alyson Parker, Martha Deahl and Ed Beltram, took the actions below on the bills during its February 4 conference call.

The work of the LAC and the LAPC provides the cornerstone for much of the dealings with members of Congress and their staff members.

H.R.4153/S.2009, Senior Legal Hotline Act of 2023 would boost federal funding for senior legal hotlines that help protect older Americans from scams and offer services for an assortment of other legal issues. It would authorize the U.S. Department of Health and Human Services' Administration for Community Living to create a competitive grant program to support organizations that operate senior legal hotlines. The proposed grant program would be authorized at \$10 million per year for five years.

-- On February 10, 2024, NRLN President Bill Kadereit sent letters to Senate Committee on Health, Education, Labor, and Pensions. Chairman Bernie Sanders (VT) and Ranking Member Bill Cassidy (LA) requesting a vote in Committee on **S.2009**.

H.R.5060/S.2627, Women's Retirement Protection Act would expand the requirement that spousal consent regardless of gender is required for plan participant actions in not just defined benefit pension plans but also defined contribution plans. This will prevent one spouse from making decisions that might undermine a couple's retirement resources without the other's knowledge and consent.

-- On February 10, 2024, NRLN President Bill Kadereit sent letters to House Committee on Education and the Workforce Chairwoman Virginia Foxx (NC-05) and Ranking Member Bobby Scott (VA-03); Committee on Financial Services Chairman Patrick McHenry (NC10) and Ranking Member Maxine Waters (CA43), and Committee on Ways and Means Chairman Jason Smith (MO08) and Ranking Member Richard Neal (MA01), requesting a vote in Committee on **H.R.5060**.

-- On February 10, 2024, NRLN President Bill Kadereit sent letters to Senate Committee on Health, Education, Labor, and Pensions Chairman Bernie Sanders (VT) and Ranking Member Bill Cassidy (LA) requesting a vote in Committee on **S.2627**.

H.R.6802, Rolling Active Pharmaceutical Ingredient and Drug (RAPID) Reserve Act would require the Department of Health and Human Services (HHS) to award contracts to quality generic drug manufacturers, who are either based in the United States or in a country that is a member of the Organization for Economic Cooperation and Development (OECD), to build and maintain reserves of critical drugs. The legislation would require awardees to keep sufficient reserves of key ingredients and finished drug products on hand and bolster production capacity to help prevent potential shortages before they occur.

H.R.6802 would also help encourage domestic production of these medications by ensuring that U.S. based manufacturers are prioritized for federal contracts. This proposed legislation builds on recommendations from 2019 and 2023 reports which found that generic drug manufacturers' ability to surge production and store supplies are often limited because they regularly operate at or near full capacity.

On September 12, 2023, the NRLN had sent a letter to Senate Committee on Health, Education, Labor, and Pensions Chairman Bernie Sanders (VT) and Ranking Member Bill Cassidy (LA) requesting a vote in the Committee on **S.2510** the companion bill to **H.R.6802**.

-- On February 10, 2024, NRLN President Bill Kadereit sent letters to House Committee on Energy and Commerce Subcommittee on Health Chairman Brett Guthrie (KY02) and Ranking Member Anna Eshoo (CA16) requesting a vote in committee on **H.R.6802**.

S.3458, Seniors' Access to Critical Medications Act of 2023 would make permanent a waiver issued by the Centers for Medicare and Medicaid Services (CMS) that allowed for Medicare patients to receive critical medications by mail or allow for caregivers and family members to obtain medications for them.

During the COVID-19 public health emergency (PHE), CMS allowed independent physicians to mail medications directly to their patients or have them delivered by a family member or caregiver, if a Medicare patient was unable to be present in the office. CMS has ruled that the end of the COVID-19 PHE marks the end of such policies. This legislation would allow for patients to have medications delivered to them via the mail, or by those overseeing their care.

On December 5, 2023 the NRLN had sent a letter to House Committee on Ways and Means Chairman Jason Smith (MO08) and Ranking Member Richard Neal (MA01), requesting a vote in Committee the on **H.R.5526** the companion bill to **S.3458**.

-- On February 10, 2024, NRLN President Bill Kadereit sent letters to Senate Committee on Finance Ron Wyden (OR) and Ranking Member Mike Crapo (ID), requesting a vote in Committee on **S.3458**.

H.R.6065/S.3102, Retirement Saving for Americans Act of 2023 would improve retirement security and financial well-being for low- and middle-income American workers. Specifically, the bill would establish a new program that gives eligible workers access to portable, tax-advantaged retirement savings accounts. It would also offer federal matching contributions for low- and middle-income workers, with the match beginning to phase out at median income.

-- On February 10, 2024, NRLN President Bill Kadereit sent letters to House Committee on Education and the Workforce. Chairwoman Virginia Foxx (NC-05) and Ranking Member Bobby Scott (VA-03) and Committee on Ways and Means Chairman Jason Smith (MO08) and Richard Neal (MA01), requesting a vote in Committee on **H.R.6065**.

-- On February 10, 2024, NRLN President Bill Kadereit sent letters to Senate Committee on Finance Ron Wyden (OR) and Ranking Member Mike Crapo (ID), requesting a vote in Committee on **S.3102**.

The LAC tabled and will monitor the following bill:

H.R.4034/S.1922 -- To amend title XVIII of the Social Security Act to provide coverage for wigs as durable medical equipment under the Medicare program.

-- The LAPC accepted the LAC's recommendation to table and monitor **H.R.4034/S.1922**
