NRLN Action Alert - Ask Representatives to Vote to Restore Delphi Salaried Retirees' Pensions

NRLN issued an Action Alert on July 25 asking not only members of the newly formed NRLN Delphi Retirees Chapter, but ALL NRLN members, to take a few minutes to immediately email the NRLN's letter and call their U.S. Representative to urge him or her to vote for the passage of **H.R.6929, the Susan Muffley Act of 2022**, to fully restore pensions for Delphi Salaried Retirees.

In the 2009 General Motors bankruptcy, Delphi Salaried Retirees were cheated out of their pensions. The federal government stepped in and fully protected GM's and the Delphi UAW unions' pensions, but the pension plan for Delphi salaried retirees was terminated, taken over by PBGC, and many of the 21,000 Delphi salaried retirees suffered payment reductions of up to 70%.

On July 27, the House passed **H.R.6929** by a vote of 250-174. Passage of this bill by the House sends a strong message to the Senate that it should pass **H.R.6929** or pass companion bill **S.3766**. NRLN Action Alert - Delphi Salaried Retirees Also Deserve Pensions Protection

On July 11, the NRLN issued an Action Alert requesting that NRLN members send the NRLN's sample letter to President Biden to urge him to take an active role with Congress to pass **H.R.6929/S.3766, the Susan Muffley Act of 2022**, The bill would wholly restore the pensions for many of the 21,000 Delphi Salaried Retirees by making up the difference between the pension benefits earned by Delphi Salaried Retirees and what they received from the PBGC following the GM bankruptcy in 2009.

The President needed to be reminded that in 2020 during his campaign for the presidency, at a stop in Alliance, OH, he said: "Look, people work like hell for their pensions. My Dad lost a pension when a company he worked for went out. It's not right! So, what I am going to do is be working with your Senators to figure out how we can bring in the salaried workers who are really hurt as badly [as the union workers], they deserve a pension."
